




Future of Leagues

Lancaster & District Curling Club



Would you like to see the Wednesday & Thursday League split into two separate night leagues?



Wednesday Night Fun League - For players that are within 2 seasons after Learn to Curl and include anyone else who wants a fun night instead of competitive.

Thursday Night Competitive (non-fixed teams/several draws) - For those curlers after 2 years of Learn to Curl graduation and anyone else interested in competitive. Scheduling leagues and making up draws is always challenging, especially when we have so many new curlers. In my past experience it's been difficult to make up balanced teams, but I know each convenor does their best. Thank you to all our board members for their efforts to encourage our new members, and to make the game enjoyable for all. You can't please everyone!

..That league has certainly changed, and I get it, because we've lost members and we gained many! Thank God for the Learn to Curl! Having said that, I along with others (who may not feel comfortable bringing it up) have found that the original model of Thursday Night Mixed was to have a somewhat competitive league that rotates teams with several draws, where all teams are balanced with relatively skilled & experienced players. It used to be a great league on Thursdays where there was healthy competition. I guess I sort of half expected it to be that way when I switched over for the last 2 draws, but to be completely honest, I found it to be very frustrating.....

Maybe divide according to experience? Under a certain number of years on one night; over that on the other.

The makeup of teams and scheduling I know is a nightmare for those responsible. I personally feel the only competitive night curling is Friday. I can't speak for the leagues that I don't curl in.
