KEEP IN MIND WE HAVE LEFT OUT AD REVENUE, BONSPEIL REVENUE AND SOME REGISTRATIONS ALONG WITH ALL DISCRETIONARY SPENDING BY THE BOARD SO THIS SHOULD WORK LIKE A WORST CASE SCENARIO.

Appendix 5

We didn't take this lightly and we met and reviewed and met some more and got some very valuable insight from Bernie. We wrote this out, so we wouldn't forget anything, so I would like to read it in full before we have any discussion. But feel free to make any notes as we go along.

Introduction: We are here to discuss the development and enhancement of our curling league, and to help develop strong, healthy league play. Our numbers are great, and the board has been doing an excellent job keeping this club thriving. We want to build on that and are offering our thoughts and experience on some areas where we think could be switched up a bit.

We realize that our Club is considered a Social Club, and it is very welcoming. Just because a Club is considered Social, doesn't mean it can't have some healthy competition. It is pretty evident that people want some competition because there is so much talk about the competitive Glengarry Cup. The Glengarry Cup rivalry of each Club's 12-person team is as

competitive as it comes. That alone says a lot. Also, we host a Mixed Invitational and to keep Clubs coming to our Club and compete here, we should be sending teams to other Invitationals like Alexandria, Vankleek Hill and beyond. We can't do that if we don't have some type of competitive growth in our own club. This is good healthy curling.

Two areas we feel need to be addressed:

- 1. Pat Lid: The historical background to Pat Lid was to end the season "put a lid on it" and play the last night or just the last draw as Pat Lid. In the past, we have tried ending our season with Pat Lid in a few Leagues like the Tuesday Ladies and the Monday Men's. Honestly, the majority really didn't like it...regular league play was much more enjoyable and beneficial. Although we do understand the reasoning behind trying a Pat Lid League, it really isn't the type of game that should be introduced to newer players as a league. We have heard from some Pat Lid participants that they haven't liked it. Although some newer curlers or recent L2C participants may like it, they may not realize they are not developing their curling skills or understanding of the game by stepping in to Skip or playing 3rd so soon. Then without realizing, they want to play in the competitive league and feel they can play Skip or 3rd. This is problematic for the experienced skips. We understand, not all new curlers feel that way and some are really learning, paying attention, and studying the game. But as a whole and a club, we feel that Pat Lid isn't developing or enhancing curling skills to the best of our abilities to have healthy leagues.
- 2. The Second area is Thursday Mixed: The 1st & 2nd draws went very well, and we had 9 teams, so we had 2 time slots of 6:00 and 7:30 a Bye. It is evident that curlers, experienced and never want to be in this more competitive league. We lost a few seasoned Skips since the first draw due to various reasons, and they will likely be back when their lives settle. We still ended up with 10 teams in this draw (6 more players). The teams still show promising balance for this January draw. Our issue is we had to add a 3rd time slot at 8:30, which can be closer to 9:00 pm, if we clean the ice. We have heard and heard again that no one likes that late time slot.

So.... Here are some Positive Suggested Solutions:

Optimizing Ice Time: There are only 6 teams in the Wednesday Pat Lid, and 10 on Thursday night, and that really isn't optimizing our ice time.

Suggestions:

Pat Lid could be introduced on open weekends similar to Doubles Days as one day bonspiels. That would create the "fun" aspect to Pat Lid. We worry as far as development, because Bernie works so hard on teaching the important "basics" to L2C participants, like balance, delivery, and sweeping and the first stages of the game. He feels, and so do we, that by introducing Pat Lid to new and less experienced curlers that the basic skills he taught will be lost. What he taught needs to be practiced and practiced. Pat Lid as a league, doesn't really provide the gradual development which follows L2C basics. Jeannine and I both worry that it might discourage Bernie and he is one of the best things that has happened to this club. We want players to build on the foundation of their L2C training and that takes time. The only way that can happen is to integrate with experienced curlers and get a better understanding of the strategy of the game. It would be beneficial if someone could reach out to Bernie, to get his thoughts since he has been the driving force (with the help of others) of curling development in this club.

Thursday Mixed: More and more members want to play competitively and although people didn't respond that well to the Wednesday, Thursday Mixed League last year, it may have been partly because the teams were not as balanced as they could have been. Asking players their preferred position in their registration doesn't necessarily mean their preferred position is the right position. This year, players didn't necessarily get their preferred position on Thursdays, but so far, the teams are relatively well balanced. We would suggest eliminating Pat Lid and combining convening with Marianne to optimize ice time, so no 3rd draw at 8:30 or 9:00 is needed either night. We could have 16 teams of balanced curling. We have taken a good look at the current Wednesday participants, and we feel there are enough experienced players between Wed and Thurs, to have 16 seasoned Skips and 16 seasoned 3rd's, to promote some exciting curling. We feel in the long run, this provides a much better experience and skill development for the less experienced player. They will eventually be our experienced curlers. We also recognize that you can't please everyone. We are here to offer our insight and help and even though some newer members may not support it, eventually they may realize it is the best thing that could happen to them. We're not here to toot our own horn. We are

here because we've been continuously asked to guide, or run a clinic, or for our knowledge, which we are more than happy to share. We believe in the club and have been around for many years. We didn't gain this experience by advancing too quickly. We gained it from our Skips before us, who we watched, we listened, we played each position for a while, and we paid attention to the game while it was being played. We feel, and so does Bernie, that after this January draw, it would be optimal to change the format to Wednesday, Thursday Mixed combined for the last few draws with 6:00 and 7:30 draws.
